Portfolio Update:

- KKC delivered a +1.50% return in June. High Yield bonds outperformed Loans over the month and B and CCC rated assets drove performance across asset classes.
- The weighted average price of the underlying KKC assets in the portfolio stood at 99.0% of par as at month end. The Yield to Maturity, which is inversely related to prices, stood at 9.1% and the current yield of the underlying assets in the portfolio was 8.4%⁽³⁾.
- European Direct Lending (EDL) had one new addition during the month, a Danish application software provider. There were no realisations. EDL represents ~41% of KKC's portfolio invested as at month end. A case study on one of our EDL deals can be found on page 3.

Distribution Update⁽²⁾:

KKC declared a monthly distribution of A\$0.0167 which equates to an annualised yield of 8.17% based on NTA and 8.75% based on the ASX unit price as of 30 June 2025. This is in line with the FY25 distribution estimate of A\$0.20. The distribution guidance for the upcoming financial year (FY26) maintains the distribution amount of A\$0.20.

Market Update:

 Easing geopolitical tensions, positive trade developments, and supportive capital market dynamics propelled the US credit market to another solid month of performance. High yield bonds experienced their strongest monthly performance in 11 months, returning +1.86%⁽⁸⁾ in June. Loans posted a gain of +0.80%⁽⁹⁾ in June, as the asset class benefited from steady retail inflows, and improving capital market conditions.




- CVC, Nordic Capital, and the Abu Dhabi Investment Authority ("The Consortium") have submitted an offer to de-list Hargreaves Lansdown from the London Stock Exchange at an enterprise value of £5.2 billion (11.2x Adjusted EBITDA).
- KKR Credit committed £750 million as the lead investor in the £1,750 million Unitranche, with KKR Capital Markets underwriting £400 million of the position to bridge the gap between the total take-and-hold commitments and the £1,750 million financing required by the sponsors.

KKC Overview

The Trust aims to provide investors with attractive, risk-adjusted returns and access to a diversified portfolio of income generating alternative credit investments through the Trust's investment across strategies managed by the credit investment teams of Kohlberg Kravis Roberts & Co. L.P. ("KKR").

These strategies comprise the Global Opportunistic Credit strategy and European Direct Lending strategy, which seek to take advantage of the attractive opportunities that KKR sees in the market. The Trust's investment objective is to provide an income stream as well as to achieve attractive long-term capital appreciation over a full market cycle.

KKC has announced that for the financial year ending June 2026, KKC is targeting a distribution of A\$0.0167 per month or A\$0.20 per annum⁽²⁾. At the current NTA of A\$2.45 per unit, that represents an annual distribution yield of $8.17\%^{(2)}$. The Trust continues to target a medium-term average total return of 6% - 8% per annum⁽⁵⁾ through business cycles.

The Trust is appropriate for investors seeking income distribution to be used as a satellite allocation within a portfolio where the investor has a 5+ year investment timeframe and a medium to high risk/return profile.
