Portfolio Update:

- KKC delivered a -0.20% return in April. High Yield bonds outperformed Loans over the month in line with broader market performance.
- The weighted average price of the underlying KKC assets in the portfolio stood at 97.9% of par as at month end. The Yield to Maturity, which is inversely related to prices, stood at 9.1% and the current yield of the underlying assets in the portfolio was 8.3%⁽³⁾.
- European Direct Lending (EDL) had three new additions during the month, a UK software provider, a UK vehicle marketplace and automotive services business, and a UK financial services provider. There was also one realisation, a Swedish software and services provider. EDL represents ~42% of KKC's portfolio invested as at month end. A case study on one of our EDL deals can be found on page 3.

Distribution Update⁽²⁾:

- KKC declared a monthly distribution of A\$0.0167 which equates to an annualised distribution rate of 8.29% of the 30 April 2025 NTA. This is in line with the announced FY25 distribution estimate of A\$0.20. As of 30 April 2025, the ASX Unit Price is A\$2.26, this represents a yield of 8.87%. The distribution guidance for the financial year ending 30 June 2026 will be updated shortly.

Market Update:

- April was a tale of two halves for investors with Trump's Liberation Day announcement sparking recession fears only to be followed by a de-escalation phase of the global trade war. High Yield bonds ended flat in a volatile month, returning +0.00%⁽⁸⁾ in April. After falling -1.81% through April 9th, Leveraged Loans staged a late-month recovery, narrowing the monthly decline to just -0.05%⁽⁹⁾.



Portfolio Case Study

Company Overview


- Founded in 2003, Alpha Financial Markets Consulting PLC (“Alpha”), is a provider of management consultancy services to the asset & wealth management (“AWM”) sector in the UK. Alpha has expanded horizontally to serve the alternatives and insurance segments, and geographically to the Continental Europe and the US, its second biggest market today.
- Alpha’s customer offering is focused on technology consulting (design and implementation), operational consulting, and specialist services for benchmarking technology vendors. The Company’s projects exhibit a high degree of recurrence with repeat clients accounting for over 95% of revenue in a typical year. The Company’s revenue model is ~80% time & materials-based and ~20% fixed fee arrangements with ~1,000 consultants across 17 offices globally.

Transaction Overview

- In August 2024, Bridgepoint approached KKR as one of the “Rule of 6*” parties to lead the financing of their public-to-private acquisition of UK-listed Alpha. KKR Credit invested £104 million across a Unitranche Term Loan and a Delayed Draw Term Loan.
- Our investment thesis is predicated on Alpha’s: (i) participation in a large AWM and insurance consulting market with strong high-single digit historical and expected growth rates; (ii) attractive leading market position in core UK AWM consulting and strong customer feedback; (iii) strategic focus within AWM and Alternatives consulting on complex change management and ops/technology improvement work which is less discretionary than other consulting spend; (iv) strong historical financial track record with ~19% organic growth between 2017-2023 (compared to ~7% market growth), ~22% EBITDA margin and >100% cash conversion due to the asset-light nature of the business; (v) strong sponsorship under Bridgepoint with relevant prior experience in the consulting and financial technology sectors from HKA, ERM, eFront, Calpyso, Fenergo among others.
- In our due diligence, we were able to leverage extensive internal relationships and experience with Alpha from various parts of the KKR organization (incl. technology, operations, finance) to build conviction on the quality of Alpha’s offering and its leading brand and market positions.

KKC Overview

The Trust aims to provide investors with attractive, risk-adjusted returns and access to a diversified portfolio of income generating alternative credit investments through the Trust's investment across strategies managed by the credit investment teams of Kohlberg Kravis Roberts & Co. L.P. ("KKR").

These strategies comprise the Global Opportunistic Credit strategy and European Direct Lending strategy, which seek to take advantage of the attractive opportunities that KKR sees in the market. The Trust's investment objective is to provide an income stream as well as to achieve attractive long-term capital appreciation over a full market cycle.

KKC has announced that for the financial year ending June 2025, KKC is targeting a distribution of A\$0.0167 per month or A\$0.20 per annum⁽²⁾. At the current NTA of \$A2.42 per unit, that represents an annual distribution yield of 8.29%⁽²⁾. The Trust continues to target a medium-term average total return of 6% - 8% per annum⁽⁵⁾ through business cycles.

The Trust is appropriate for investors seeking income distribution to be used as a satellite allocation within a portfolio where the investor has a 5+ year investment timeframe and a medium to high risk/return profile.

KKR Overview

Established in 1976, KKR is a global investment firm with industry-leading investment experience, a pioneering attitude to ESG management and a strong culture committed to teamwork.

As of 31 March 2025, KKR had A\$1,064.6 billion of assets under management, of which A\$406.7 billion sits within KKR Credit.⁽⁶⁾
